# PROPOSED PROCEDURE FOR SELECTING A TOP-LEVEL DOMAIN STRING FOR PRIVATE USE

- The Public Comment Proceeding must allow for comments about the selected string.

# GNSO GUIDANCE PROCESS APPLICANT SUPPORT GUIDANCE RECOMMENDATION INITIAL REPORT

While the RySG supports all GGP recommendations as written, the comment raised that the report does not give all implementation guidance that ICANN Org will need to structure the Applicant Support Program in a more effective way compared to the 2012 program. Charter questions/tasks were all answered, but whether additional tasks or a vehicle other than a GGP could have delivered a suitable outcome, will be up to the GNSO Council to assess in its continuous management of the policy process. For now, we strongly suggest this item gets into the SubPro IRT agenda sooner rather than later, since this program is in the critical path of subsequent procedures. We also believe that bringing outside expertise to help in the program implementation could increase its likelihood of success, for a definition of success that the GGP established.

#### PILOT HOLISTIC REVIEW REVISED DRAFT TERMS OF REFERENCE

#### TRANSFER POLICY REVIEW PDP – EARLY INPUT ON GROUP 2 TOPICS

#### RYSG FEEDBACK ON THE DRAFT FRAMEWORK FOR CLOSED GENERIC GTLDS

The Registries Stakeholder Group (RySG) shared concerns about the basic definition of a closed generic and noted that this is not a policy development process. While the RySG expects this work could provide important input into a policy development process, it noted that the GNSO PDP must be undertaken if there is to indeed be policy developed on this issue. The RySG comments are based upon the understanding that this is a Board directed process and not a formal policy development process. The feedback includes overarching comments, areas that are unclear and could present broad scope concerns, and practical implementation issues.
